TPWU Official Convention Call

Members of the Texas Postal Workers Union, AFL-CIO, will convene in San Antonio, TX at 10:00 am, Thursday, June 29, 2023 through Saturday, July 1, 2023, for the 38th TPWU Biennial Convention. The official Convention Headquarters will be at the La Quinta Inn & Suites by Wyndham San Antonio Riverwalk, 303 Blum St., San Antonio, TX 78205

Reservation Method/Procedure

Reservations will be made by IN-DIVIDUAL CALL IN/BOOKING LINK: on or before 6/13/2023.

Please be prepared to provide credit card information to guarantee reservations. No blocking rooms, each room **must** have a name of the guest.

An online booking code will be provided to the group once the block is loaded in the HOTEL's reservation system. Shoulder dates may not show as available when booking online. Please contact the HOTEL Sales department for assistance.

RESERVATION CUTOFF DATE

The guest room block will be held

until 6/13/2023 which is 14 days prior to arrival or until such time as the block has been filled. Any sleeping rooms not reserved by the cut-off date shall be released by the HOTEL for sale to the general public. Additional rooms for the GROUP may be reserved on a space and rate availability basis. Established GROUP guestroorn rate is not guaranteed to be extended after the cut- off date.

INDIVIDUAL ROOM RESERVATION CANCELLATION/NO SHOWS

Individual room reservations must be cancelled at least 24 hours prior to the reservation arrival date (6pm CST). All GROUP reservation cancellations received within 24 hours of arrival will be charged a cancellation fee of one night's room and tax. All guaranteed reservations will be held until 12:00 AM on the day following the arrival date. Should a guest fail to check-in by this time, a no-show

charge of one night's room and tax will be assessed, unless guest makes prior arrangements with the HOTEL for .late arrival.

CHECK-IN AND CHECK-OUT

The HOTEL does not release any guest room keys while guest rooms are in the process of cleaning. Standard checkin time is 4:00 PM or later and check-out time is by 11:00 AM on the day of departure. Reserved rooms will be ready for check-in by 4:00 PM. Any unauthorized stayover after the 11:00 AM check-out time will be charged a full day rate.

Additional charges may be assessed unless Rooms Division Manager approves check-out extensions.

EARLY DEPARTURE FEE

In the event a guest departs prior to scheduled departure date, a fee of \$75.00 per room will apply. Fee will be waived in the event of an emergency.

Resolutions should be typewritten and submitted in duplicate. The Local Secretary should attest to Resolutions submitted by a local. Resolutions must contain the following information:

1. The title of the subject matter.

2. The name of the delegate(s) or local sponsoring the Resolution.

3. The body or text of the Resolution. Note: Please put only one (1) Resolution on each page.

All Resolutions will be referred to the appropriate committee. Resolutions with the same basic subject matter will be consolidated. Consolidated Resolutions will bear the name of each local submitting a similar Resolution. All Resolutions will be brought to the floor for a vote.

After May 1, 2023, Resolutions will be accepted by the Secretary providing they are submitted in 300 copies. Those dealing with subjects not otherwise submitted will be referred to the appropriate committee. Time permitting, all Resolutions submitted after May 1, 2023 will be reported out of committee and bought to the floor for a vote.

TPWU Election Nominations

The Texas Postal Workers Union will hold nominations and elections at the 38th Biennial TPWU Convention to be held at the La Quinta Inn hotel. Nominations for the following positions will be conducted on Saturday, July 1, 2023.

- Vice President

- Secretary-Treasurer
- Director of News Information/Website-Editor
- Clerk Craft Director
- Maintenance Craft Director

Elections will be the first order of business on Saturday, July 1, 2023. All offices will be for a term of two (2) years. Nominations for Delegate(s) to the National Convention will also be taken at this time. The number of elected Delegates shall be two (2) and one (1) Deaf and Hard Hearing Delegate.

Credentials and Registration

To ensure proper handling of credentials and expedite the registration, please adhere to the following guidelines:

- 1. List Delegates' names in alphabetical order for your local or Membersat-Large (MAL). Be sure the President and Local Secretary-Treasurer both sign the forms. (Whichever applies to your Local Constitution)

3. Registration fee is \$95.00 per Delegate if received by close of business on May 1, 2023. Any Delegate registering after May 1,2023 will be charged \$105.00 per Delegate for late registration.

Make all checks payable to the SAAAL #195.

4. Keep a copy of the Registration Forms and checks submitted. Be sure and bring the copies with you should there be any questions concerning and verifying registration.

- 5. Make additional copies of your blank Credentials Forms, should your Local send more than ten (10) Delegates.
- 6. Indicate if the Delegate is Deaf/ Hard of Hearing.
- 7. Make sure to list any Alternate Delegates.
