Deferment periods for all jobs **Pending Qualification** shall begin **the date the Senior Bidder reports for Training**. If employees **Do Not Report** to the Training Office, Room 1011B, the deferment period will begin **TEN DAYS** from the **date of this Award Notice**.

When a duty assignment requires scheme knowledge and/or machine qualifications and when “an employee has scheduled leave of a week or longer [four (4) days during a holiday week] within the first twenty-eight (28) days, may **AT THEIR OPTION**, begin training upon return from the scheduled leave.”

Any employee awarded a job **requiring Typing skills** will be scheduled and notified where and when to take the typing examination.

Any employee awarded a job **requiring Driving requirements** must report to the Training Office within **TEN DAYS** from the **date of this Award Notice** to complete necessary paperwork.

Any employee **TEMPORARILY DISABLED** must provide **MEDICAL CERTIFICATION**, to District Health & Resource Management (previously Injury Compensation) with a copy to Manager In Plant Support ATTN: Mauro Tapia, indicating that the employee will be able to **FULLY PERFORM** the duties of the bid for position **WITHIN SIX (6) MONTHS** of the bid. If the employee **FAILS** to provide such certification **WITHIN 10 DAYS FROM POSTED DATE OF AWARD**, the bid shall be **DISALLOWED**, and if the assignment was **AWARDED**, the employee shall become an **UNENCUMBERED EMPLOYEE** and the bid will be **REPOSTED**. Under such circumstances, the employee **SHALL NOT** be eligible to re-bid the next posting of that assignment.

Live Bid Request (Clerks) – Local Services should submit a JB-1100 – Live Bid Request for employees who were designated as successful bidder and wishes to remain a live bidders on other bids.

Please Note: The employee must notify management in writing within 10 days of his/her election to remain a bidder on one or more of those assignments. Failure to notify within ten days will cancel such other bids. (Article 37.3.F.8.a)
